Nominations received after the May 9, 2017 electronic mailing to Affiliate Representatives and Alternate Representatives will be included in the nominations sent to the floor at the Annual Meeting. **Important: A Credentialed Affiliate Representative or Affiliate Board Member must sign the nomination form.**

Incumbents need to be nominated for re-election. Contingent nominations for other director positions may also be submitted. A contingent nomination is sometimes made in the event the incumbent or another candidate is elected to a higher office (i.e., Vice Chair).

NWF Bylaws (Article V(c)) state Affiliate Representatives intending to nominate someone for office should advise the Secretary of the name of their intended nominee at least 48 hours prior to the election. Under *Robert's Rules of Order Newly Revised*, nominations can be made from the floor and will remain open until a motion has been passed to close nominations. **However, the Notice of Nominations Received will be mailed out on May 9, 2017, and only those candidates for whom a nomination has been received prior to this mailing will be included in the notice.**
