



## Alaska Survey Results

**Q1** Do you approve or disapprove of President Donald Trump’s job performance?

*Approve* ..... 49%  
*Disapprove*..... 48%  
*Not sure* ..... 3%

**Q2** I’m going to tell you a little bit about the Land and Water Conservation Fund, which Congress has the chance to reauthorize this year. The Land and Water Conservation Fund was created by Congress 53 years ago to bolster the health of Americans by ensuring they have places to recreate outside. It has funded efforts in every county in every state in the country—things like parks, wildlife habitat and municipal swimming pools and it is not funded by taxpayer dollars. Having heard this, do you support or oppose renewing and funding the Land and Water Conservation Fund?

*Support* ..... 63%  
*Oppose* ..... 15%  
*Not sure* ..... 22%

**Q3** I’m going to read you some reasons why supporters of the Land and Water Conservation Fund say it should be renewed, and after each one, ask you if you find it a very convincing, somewhat convincing or not a convincing reason to permanently renew the program. Here’s the first one: the Land and Water Conservation Fund helps kids and their families get outside. Do you find this a very convincing, somewhat convincing or not a convincing reason to permanently renew the program?

*Very convincing* ..... 35%

**Q4** Here’s the next one: The program protects important wildlife habitat – do you find this a very convincing, somewhat convincing or not a convincing reason to permanently renew the program?

**Q5** Here’s the next one: The Land and Water Conservation Fund supports the outdoor economy – which each year generates \$887 billion in consumer spending and helps support 7.6 million jobs. – do you find this a very convincing, somewhat convincing or not a convincing reason to permanently renew the program?

**Q7** Having heard all the information in this survey, let me ask you again: do you support or oppose renewing and funding the Land and Water Conservation Fund?

**Q8** If Senator Lisa Murkowski voted to authorize renewal of the Land and Water Conservation Fund, would that make you feel more favorable or less favorable towards her, or would it not make a difference?

**Q9** It's possible that Congress might technically renew the Land and Water Conservation Fund, but not permanently fund it with the necessary money, which would prevent the program from continuing as effectively as it has. If Senator Lisa Murkowski voted to renew the Land and Water Conservation Fund but not fund it, would that make you feel more favorable or less favorable towards her, or would it not make a difference?

*White* ..... 75%  
*Other* ..... 25%

**Q14** If you are 18-45 years old, press 1. If 46-65, press 2. If older than 65, press 3.

*18 to 45* ..... 28%  
*46 to 65* ..... 46%  
*Older than 65* ..... 27%
