Campus Environment 2008 recognizes more than 334 individual schools for having exemplary levels of sustainability activities and plans to do more, as determined by survey responses. Campuses with relatively high numbers of exemplary marks include Willamette University in Salem, Oregon; the Georgia Institute of Technology, Atlanta; Michigan State University, East Lansing; University of Arizona, Tucson; University of North Carolina at Chapel Hill, and Cascadia Community College in Bothell, Washington. Dozens of other campuses are also recognized in the report for specific programs.
